This amnesty is offered for the period March 22nd to June 30th, 2021.

During the amnesty, persons applying to regularise an illegal connection and receive a valid T&TEC account, will avoid disconnection, administrative and interest charges, back billing charges for the period of the illegal connection and legal prosecution, in accordance with the Trinidad and Tobago Electricity Commission Act.

Applicants are responsible for all costs related to wiring and inspecting their property and acquiring the documents listed below. To benefit, the applicant must complete any required work and then submit the documents, during the amnesty period. Failure to do so can result in a loss of supply until the work is completed.
