# **Editorial**

On June 15th, United States President Barrack Obama, in a national address regarding the response to the BP oil spill on the Gulf coast, used these words to describe the situation: "Already, this oil spill is the worst environmental disaster America has ever faced. And unlike an earthquake or a hurricane, it's not a single event that does its damage in a matter of minutes or days. The millions of gallons of oil that have spilled into the Gulf of Mexico are more like an epidemic, one that we will be fighting for months and even years."

The irony that this spill occurred on Earth Day, and one month before World Environment Day (WED) observances has not escaped the attention of many.

Initial media reports stated that the threat of the oil spill to the Caribbean was slight, but the relative unpredictability of the hurricane season is an unknown factor, the effect of which the experts so far have been unable to fully quantify. While the U.S. focuses on recovering from this incident it has served as a harsh reminder that we all need to pay greater focus on environmental protection.

This does not necessarily require national effort- though that too is needed- but individual and corporate responsibility.

At home, T&TEC remains committed to the protection of the environment. We are currently in the process of obtaining ISO 14001:2004 registration and certification for our Environmental Management System (EMS). The EMS is a comprehensive system that will direct our efforts in Water conservation, Energy Conservation, Paper Conservation and Spill Prevention and Response. The measures are detailed in the Waste Management Programme component of the EMS.

Already Distribution Central and Tobago have major projects that protect the environment through Spill Prevention and Response/Mitigation. At the Cove Power Station there is also a system in place for capturing all the waste oil used in the generation process and transferring it to the appropriate agencies for recycling. Several areas also have continuous projects in paper conservation, recycling and waste reduction.

As the Health and Safety Department finalises the EMS for formal introduction throughout the Commission, it is

appropriate to start, if you haven't done so already, thinking about how to get involved on a personal level. Consider it a personal challenge to change the way you operate on the job and away from the office. Review the recommendations from the General Manager in his WED message to employees, and consider this: one carton (10 reams) of 100% virgin copier paper uses 0.6 trees. How many reams of paper does your department go through each month? By reusing or recycling paper, thereby reducing the demand for paper, you can help save thousands of trees annually.

Paper conservation is perhaps the easiest step to take but more and more community level NGO's are being set up to facilitate the recycling of plastic bottles, in addition to those that already recycle paper. Recycling plastic bottles, or, even better, using reusable bottles, can remove an estimated 12,162 plastic bottles from Trinidad and Tobago's beaches annually.

If your department or community doesn't yet have any programmes in place to benefit the generation consider becoming a champion for the cause.

# **Reform Substation Commissioned**



The Reform 132 kV switching station forms an integral part of the 132 kV south transmission programme. The 132 kV switching station was commissioned in December 2009. The site also houses the new Reform 12 kV Substation which was commissioned in March 2010.

The Reform 132 kV switching station consists of nine 132 kV circuit breakers. Two additional 132 kV circuit breakers would be installed, in the near future, to provide Petrotrin with a 132 kV supply, to cater for the demand which would arise out ofthe comapny's refinery upgrade exercise.

Since the load was approaching the Substation's capacity, it was necessary to establish a 12 kV distribution Substation in the Harmony Hall/ Reform area to provide, both for relief of the Harmony Hall Substation and, more importantly, for load growth over the next few years.



The Reform 12 kV Substation project consists of the installation of two – 132/12 kV, 30/40 MVA transformers and an 11 panel switch board with associated protection, metering, communication and other supporting equipment. The Substation will greatly improve the reliability of supply to communities in Gasparillo, Harmony Hall, Williamsville, Mayo, St. Joseph Village, parts of San Fernando and environs.

All 12 kV distribution work, including assembly of the transformers and the construction of the overhead line 12 kV feeders were done by Distribution South. Other Departments that were engaged in this project included: Protection & Scada, Communications and Networking and System Planning and Control.

# The power to make it work... in Otaheite

On 25th April, 2010 the new Otaheite Substation was energized. This new Substation would provide a reliable supply of electricity to the largest WASA booster station in the southern part of the country that is currently under construction, S. M. Jaleel, and other Residential, Commercial and Industrial customers in the area.

The Otaheite project entailed the construction and commissioning of the Penal-Otaheite 33 kV and Fyzabad-Otaheite 33 kV overhead transmission lines.

The Otaheite Substation is outfitted with indoor 33 kV SF<sub>6</sub> gas insulated switchgear.

Distribution South's Substation Engineer, explained that the Commission adopted the indoor design due to the space limitations at the site. It is also, no doubt, aesthetically pleasing.









# **Progress of Gateway Substation**

As reported previously, the Commission has embarked on an expansion programme which included extending the 132 kV system into Port of Spain.

On completion of the project, the reliability of supply to the City of Port of Spain and its environs will be significantly improved.

The Gateway project was started in 2007 and entailed the following:

- The construction of a 132 kV double circuit tower line from the Bamboo Substation to the Sea Lots area.
- The construction of a 132 kV underground cable system from Sea Lots to Gateway Substation located at Flament Street next to the Port of Spain Substation.
- The establishment of the Gateway 132/33 kV Substation. The design incorporates both a 132 kV and a 33 kV indoor gas-insulated switchgear.

The Gateway Substation is intended to replace the 40-year old 33 kV switchboard at the Port of Spain Power Station. Lately, there have

been a number of faults on this old switch board, which have affected the reliability of supply to the City.

Needless to say the project has presented numerous challenges to our engineers. One example was the difficulty in finding a suitable line route from Bamboo to Sea Lots- bearing in mind the line traverses wet landsand dealing with those environmental challenges while adhering to environmental laws.

Another challenge was finding a cable route from Sea Lots to the Gateway Substation while considering Developments such as the Hyatt Regency and other large buildings along this route.

Crossing Wrightson Road, Port of Spain with this cable is also a challenge as various services – the city's waste water system and salt water mains, together with, underground telephones and natural gas lines – are buried beneath the route.

While engineers grapple with these and other challenges, the Commission remains confident that they will find acceptable solutions.

At present, the 132 kV line has been installed. Also, a contract for the remaining part of the underground duct work to accommodate the 132 kV cables, in the vicinity of the Hyatt Regency, will be awarded soon. The 132 kV and 33 kV Switchgear have been installed and tested. Work has already started on the installation of two 132/33 kV, 100 MVA transformers, which are already positioned on their respective plinths. Bearing no unforeseen problems with the installation of the cable crossing under Wrightson Road, the Gateway project is expected to be completed by the 1st quarter of 2011.

The success of this project is credited to the Transmission Development and Engineering Services Department who has been charged with the

> responsibility to design, develop and execute the Gateway Project. Undoubtedly, the Project is a difficult one to execute, but the men and women of this Department have risen to the challenge.

# Employees encouraged to protect the Environment

On June 5th, World Environment Day (WED), we were all asked to heed the call to improve the state of the environment in which we live. Over one month has since passed; can you say that you have heeded that call?

This year's WED theme was "Many Species...One Planet...One Future." In his WED message to employees, the General Manager, Mr. Indarjit Singh spoke about the Commission's plans to have its Environment Management System (EMS) registered and certified under the ISO 14001:2004.

A number of initiatives, born out of the EMS, are specifically targeted towards waste management, and are listed under T&TEC's Waste Management Programme (WMP). The WMP is a tool designed to deal with the handling, storage, transporting, disposal and tracking of all waste created as a result of the Commission's operations.

In the Oct-Dec 2009 issue of the Wats Happenhad we highlighted some of the projects - disposal of paper, water and energy conservation - that were implemented by Distributions Central and Tobago, the Areas selected for piloting the EMS.



The Environment Management System (EMS) is a tool used to manage our environmental obligations and aspirations. It is already being implemented in Distribution Central and Tobago.

Since that time, a number of other initiatives were introduced. These included:

# The Construction of a Bio-Remediation Site Located in the Central Area Sports Club's backyard, this project was completed last February.

The site is designed to relieve the problem of oil pollution, by using living microbes to transform harmful substances into non-toxic compounds. When soil is contaminated, it is excavated and transported to the biosite. Bioremediation process is initiated with the use of an enhanced microbe liquid suspension. The soil is filled and watered daily so that the bacteria in the Gator Wash will have an adequate amount of air and moisture to live and perform its biodegrading activities.

#### • Spill Prevention Programme

Defective transformers are placed in reused barrels to prevent spills during transportation from the worksite to the waste storage site at Tobago Area's compound. At this point the mineral insulating oils within the transformers are pumped and stored in special containers for disposal.

Maintenance work on all oil-filled electrical equipment is carried out on sorbent mats or with sorbent fabrics to contain spills and leaks.

The Waste Management Programme, under the EMS, will soon be rolled out to all of the Commission's Distribution Areas. Its success will depend on the support and participation of all employees. Be ready to heed the call for environment protection. It is everyone's

responsibility. Remember, every act, no matter how small, will contribute towards the preservation of our planet.

# RIC revises T&TEC's performance standards



Effective April 1, 2010, the Regulated Industries Commission (RIC) has revised the Guaranteed and Overall Electricity Performance Standards for T&TEC.

The new standards feature higher performance levels; increased penalties and automatic compensatory payments for breaches under all Guaranteed Electricity Standards, except GES 1.

The following is a summary of the new and improved GES and OES.

## NEW GUARANTEED ELECTRICITY STANDARDS (GES):

- GES 5 Investigation of voltage complaints:Visit within 24 hrs; Correct within 15 working days.
- **GES 6** Response to billing and payment queries: Give a substantive reply to written queries within 15 working days.

# IMPROVED GUARANTEED ELECTRICITY STANDARDS (GES):

- GES 1 Restoration of supply after unplanned outage: Restore supply within 10 hours (2 hours quicker than previous GES 1) up to 200% increase in penalty payments for breach.
- GES 2 Billing Punctuality for new customers:

  Mail first bill within 60 days to Residential and
  Commercial customers, and within 30 days
  to Industrial customers (5 days earlier than the
  previous GES 2).
- GES 7 New connection of supply:

  Connect within 3 working days (Previous Standard ranged from 3-20 days).

#### THE FOLLOWING GES REMAIN UNCHANGED:

- **GES 3** Reconnection of electricity within 24 hours after settling overdue amounts or reaching agreement on payment schedule.
- **GES 4** 24 hours notice of our inability to keep an appointment.

GES 8 - Compensatory payments owed under Guaranteed Standards within 60 working days for Residential and Commercial customers and within 30 working days for Industrial customers.

#### **NEW OVERALL ELECTRICITY STANDARDS (OES):**

- OES 3 Visit or give a substantive reply when responding to meter problems within 10 working days, 95% of the time.
- OES 5 Repairs to street lights:
  Repair 100% of failed street lights, with the exception of highway lighting, within 7 working days.
  Repairs 100% of failed highway lighting within 14 working days.
- OES 7 Response to claims:
  Notify 100% of all customers of T&TEC's
  receipt of claim under Guaranteed Standard
  GES1, within 10 working days.

#### THE FOLLOWING OES REMAIN UNCHANGED:

- OES 1- Read 90% of Industrial meters every month.
  Read 90% of Residential and Commercial
  meters according to schedule.
- OES 2 Mail 98% of electricity bills within 10 working days after meter reading.
- **OES 4** Give 3 days advanced notice of planned outages 100% of the time.
- OES 6 Give a substantive response to written customer queries/requests, within 10 working days and communicate final position within 30 working days.

These standards spell out the accepted quality of service levels that the Commission must achieve. We are therefore required to work diligently towards meeting and exceeding these stipulations. Remember, it is our customers' right to a safe, reliable, high quality electricity supply.

# ISO 9001...

# A leap in the right direction

T&TEC's quest to acquire ISO 9001 Quality Management System (QMS) certification for its Distribution operations took a positive leap when the pilot project at Distribution South was pre assessed in March this year. White Hopering spoke to Mr. Vishnu Seetaram, Assistant Area Manager and ISO Coordinator for Distribution South on the recent audit.

The pre assessment of our Distribution operations was conducted by National Quality Assurance (NQA), USA over two days (March 31 and April 1). The NQA team comprised Mr. James E Dozier, General Manager and Mr. Steve Marquedant former General Manager and now Associate Auditor.

In presenting their findings, the NQA team noted how impressed they were by the levels of customer focus and the effort and enthusiasm shown. According to Mr.

Seetaram, the NAQ singled out the Commercial section for high praise. Some amendments however, were highlighted and timelines were set for effectively implementing the recommendations."

The Distribution South ISO team is currently working on ensuring that these recommendations are implemented, and are confident that they will be ready for final ISO assessment by August this year.

# T&TEC and OWTU approach 40 year milestone

Forty years is a long time. So when the Oilfields Workers Trade Union (OWTU), in 1969 became the official bargaining body for T&TEC's monthly and hourly-paid workers, one might not have imagined a spell that long. For 23 years prior, between the years 1946 to 1969, the Commission had no less than four unions representing the interests of workers.

But stability came in the form of the George Weekes-led OWTU, which successfully challenged the Federated Workers Trade Union (FWTU) and the Electricity Supply Industrial Union (ESIU) in 1969 for recognition as the Commission's bargaining body.

The next year, 1970, the OWTU led negotiations for improved salaries and working conditions for monthly-paid workers and on December 14th, the first OWTU/T&TEC labour agreement was signed. Seventeen years later in 1987, the T&TEC Board of Commissioners included a union representative for the first time. That person was the then OWTU President General, Errol Mc Leod.

The OWTU has provided over forty years of unparalleled quality representation for T&TEC workers. And as said by former General Manager of the Commission, Mr. Leo Martin, "...the relationship between the Commission and the union was never a divisive one in spite of the differences which normally accompanied the resolution of industrial relations issues".

On June 19th workers across Trinidad and Tobago recognised Labour Day. It is therefore an opportune time for us to remember the work of the labour movement in Trinidad and Tobago and in particular, T&TEC, especially stalwarts like Mr. George Weekes, Mr. Errol McLeod, Ms. Helen Rambally (T&TEC's first woman employee to have served as an official on the OWTU), and the many others who paved the way for the revolutionary OWTU as we know it.

# About transferring an account following the death of a customer.

#### Here is what is required:

- ✔ Proof of ownership of premises to be connected. e.g. Title Deed, Deed of Assent, Deed of Gift, Deed of Mortgage, Deed of Lease.
- ✓ A letter from an Attorney-at-law confirming that the letters of administration/probate has been applied for and that the applicant is the Administrator/Executor of the Estate.
- ✓ The Meter number and meter reading and date, as near possible to the date of transfer.
- ✓ An arrangement for the settlement of balances in the name of the deceased depending on the circumstances.

# What's in a shape? Compact Fluorescent Lamps

Compact Fluorescent Lamps (CFLs) are modern types of light bulbs that work like fluorescent bulbs, but in

a much smaller package. They produce little heat which makes them less of a fire risk and are very efficient (about 300-400% more than incandescent bulbs). CFLs normally last between 7,500 to 10,000 hours, about 10 times more than a standard incandescent (750 to 1,000 hours).

CFLs come in many shapes and sizes - Spiral Lamps; Tube Lamps; Incandescent A-line fluorescent; Globe fluorescents; Candelabra, Post or Bullet shape fluorescents and Outdoor reflector fluorescents

Risk Assessment and Job Hazard Analysis –

vital tools in the prevention of workplace accidents

"Risk Assessment, a requirement of the OSH Act, allows us to put in place proactive measures for planning, managing, supervising and executing all works in the Commission." Mr. Indarjit Singh, General Manager.

T&TEC's Risk Assessment document (2009) defines a risk assessment as "the process of systematically identifying hazards and estimating their consequence and probability of occurrence to arrive at a risk level to guide and apply the necessary control measures." To successfully complete this process and improve employee safety, the Commission requires that a Job Hazard Analysis (JHA) be conducted before any work is done.

The issue of Job Hazard Analysis is timely as the theme for National Safety Week 2010 (April 26th to April 30th) was "Securing the Future: emerging risks and new patterns of prevention in a changing world of work."

In his Safety Week message to employees, General Manager, Mr. Indarjit Singh reminded us to place work safety high on the agenda. As he said, "investment in the safety and health of our employees must be seen as integral to fulfilling T&TEC's mandate to its customers, the nation and ourselves."



Employees must be aware that along with the usual risks associated with working in the electricity industry, other hazards are also present. These include working in designated 'hotspot' areas, crime and violence, use of illegal drugs, smoking in public spaces, natural and manmade disasters and infectious diseases.

Supervisors have a responsibility to observe these steps to prevent the incidence of workplace accidents.

#### Job Hazard Analysis is relevant because it:

- 1. Identifies job hazards
- 2. Determines safety rules/procedures to be followed
- 3. Determines PPE to be used
- 4. Identifies all sources of energy/supply
- 5. Ensures that hazards are controlled
- 6. Ensures that all PPE are worn before work starts

### **Electrical Safety Awareness**

To coincide with National Safety Week, T&TEC held a Safety Awareness text competition to test the public's awareness of electrical safety and to educate others. The competition was aired on CCN TV6. Celise Patrick-Alfred was the first place winner and Victoria Joseph and Sheena-Ann Ramsaroop both won consolation prizes.

# Pensions Corner

### Here is what's new from the Pensions Department.

# ENHANCEMENT OF PENSION PLAN BENEFITS

#### Increased Monthly Pensions

Our May 2010 payroll is anticipated to significantly reflect the impact of the following provision:-

"Basic pension shall be increased by five hundred dollars (\$500.00) per month from January 2006. Effective 1st January 2007, 2008 and 2009 pensions shall be adjusted annually in accordance with changes in the Retail Price Index (RPI) capped at five percent (5%) per annum, subject to the maximum payment allowed under the Pension Plan."

#### Employee Home Ownership Plan (EHOP) Loan Facility

Our Trustee, Republic Bank Limited (RBL) has been instructed to implement the following provisions:-Effective from the 1st March 2010 the EHOP loan limit shall be increased to \$750,000.00 for all eligible members.

The existing EHOP Rules remain intact. Copies of such Rules can be sourced from the Pensions Department and/or viewed on the Intranet.

Existing mortgagors are reminded that all requests for refinancing of existing facilities must be directed to the Pension Plan Committee through the office of the Pension Plan Administrator.

The interest rate applicable shall be reduced from five percent (5%) to three percent (3%) with effect from January 1, 2006.

The retroactive benefit arising from the implementation of this reduction in the interest rate will be applied to outstanding balances held to members' accounts.

Where members' balances have been fully repaid, however, not for refinancing purposes, direct refund settlements will be processed to the members concerned.

#### Bridging Loans

Members who are eligible for long term loans under our EHOP facility are advised that RBL has agreed to provide bridging financing on same with an eight percent (8%) rate of interest per annum.

This offer is not extended to other loan arrangements.

#### Evidence of Life

Many Pensioners made an effort to comply with the requirements for life certificate at the end of March 2010. Thank you.

Remember the second quarter submissions of Life Certificates are due on 30th June 2010.

#### Nomination of Beneficiary Form

Several members have submitted notices of 'Change of Names' arising from recent marriages. You are reminded to review and update your Beneficiary Forms, as necessary, to ensure that they reflect your wishes. Minors can be nominated as beneficiaries.
